The board discussed the rezone request from Leroy Miller to rezone 2 acres from Ag 1 to Ag 3(2) for the purpose of an Amish cemetery. The Land Use Planning Commission recommended to the board to approve the request. There was a motion by Jan Banicki to approve the Rezone as requested. Second by Roger Wallis. The ordinance was read and signed by the town board-witnessed by the clerk.

The board discussed the Routes to Recovery Funding for Covid 19 expenses. Motion by Roger Wallis to approve up to \$15,000 to install an exit door in the building and to have Service Master come to clean inside of the Hall with a Hepa Vacuum and special cleaning agents for disinfecting. Second by Jan Banicki.
